Our mission at Gilda's Club South Florida is to ensure that all people impacted by cancer are empowered by knowledge, strengthened by action, and sustained by community. We accomplish this by providing a comprehensive program including support groups, healthy lifestyles workshops, educational programs, and social activities to all those impacted by cancer.

PROGRAM HIGHLIGHTS

LBT OUTREACH PROGRAM: Touched by Cancer: Women Partnering with Women was launched to address the disparities in cancer care for LBT women. 213 women attended community-based programs.

PROGRAM EXPANSION: With a focus on creating lasting and impactful community partnerships, Gilda's Club has its first cancer support group at an outside location, Gilda's on the Go - Weston in Cleveland Clinic.

3,100

middle and high school students in 128 classrooms that participated in Kids C.A.N. - Cancer Awareness Now, a fun and informative cancer education program.
