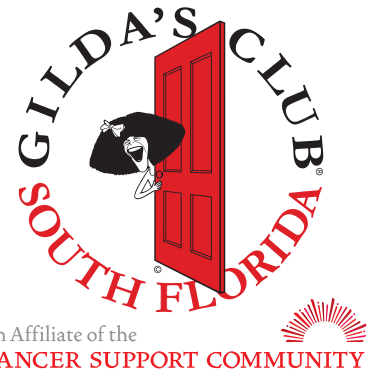


IMPACT REPORT 2019

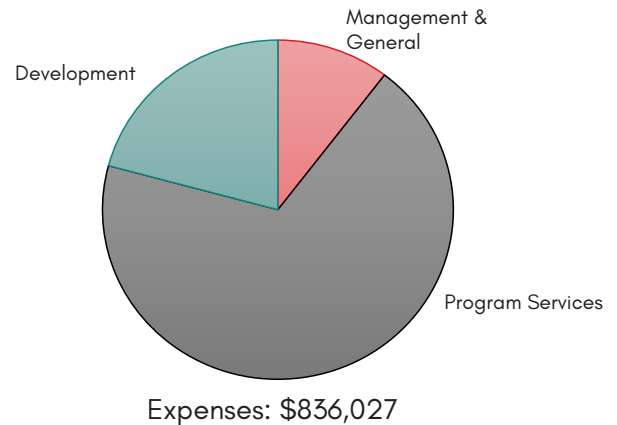
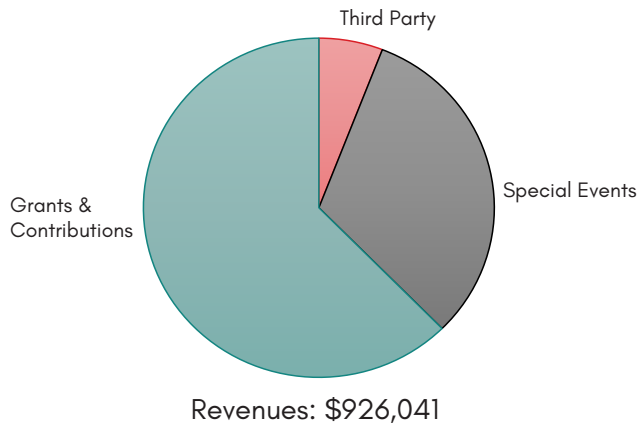
